- 3. The Advocate/ Law Firm desirous of applying for empanelment may submit duly filled Application in the Format provided at Annexure-A.
- 4. The fee of the empanelled Advocate/ Law Firm shall be strictly governed by the CCl Fee Structure provided at Annexure-B as amended from time to time. Further, no Retainer Fee shall be paid to the empanelled Advocate/ Law Firm merely on account of being empanelled.
- 5. The empanelled Advocate/ Law Firm must refrain from contesting a case against the CCI.
- 6. The Applications are invited in sealed envelope superscripted as "Application for empanelment of Advocate/ Law Firm". The sealed envelope containing the hard copy of Application along with enclosures must be submitted by post to or delivered in person at the concerned Units of the CCI as provided at Annexure-C. The Application must be typed and submitted on A4 size paper, spirally and securely bound and with all pages therein in serial order. All pages of the

- 7. The Application shall be made only for one region as provided under Annexure C and empanelment of the Advocate/ Law Firm shall be for that particular region only.
- 8. The last date for submission of Application is 15.05.2023 till 05:00 PM.
- 9. On scrutiny, any Application not found in desired format/illegible/incomplete/not containing clear information, or failing to fulfil the eligibility shall be rejected for further evaluation at the sole discretion of CCI.
- 10. The short listing or empanelment by CCI shall not create any right in favor of the shortlisted or empanelled Advocate/ Law Firm to be engaged as dealing Advocate on behalf of CCI.
- 11. CCI reserves the right to accept or reject any or all Applications without assigning any reason whatsoever and the CCI decision in this regard shall be final.
- 12. Empanelment of Advocate/ Law Firm shall be liable to be cancelled on the occurrence of any of the disablements provided at Annexure-D.
- 13. CCI reserves the right to verify the validity of information provided in the Application and reject any Application where the contents appears to be incorrect at any time during the process of empanelment.
- 14. The Applicants shall bear all costs associated with the submission of the Application for empanelment. The interested Advocate/ Law Firm may submit the Application in the prescribed Format addressed to the General Manager of the Units.
- 15. The Advocate/ Law Firm empanelled with the CCI need not submit Application for empanelment.

 'Effective Hearing' shall mean a hearing in which either one or both parties involved in a case are heard by the Court/ arguments were advanced by the Counsel of any of the parties.

'Non-effective Hearing' shall mean all hearings which are not covered in the above definition of effective hearing inclusive of the case adjourned without any hearing/ arguments of the Counsel due to non appearance of other party Counsel or if the matter does not reach the board on same dy.

3. 'Similar Cases' shall mean two or more cases in which identical or substantially similar questions of law or facts are involved

When two or more cases involve substantially similar or identical questions of law and/or fact, one of such cases will be treated
as the main case and the others as connected cases and the fees in such cases will be regulated as under, provided the cases are
heard together.

ii. Full fee would be admissible for appearance in the main case and 50% in each of the connected cases, subject to a maximum of one additional full fee, i.e. not more than twice the amount of full fees in the main case would be admissible irrespective of number of such connected cases.

iii If substantially identical petition/plaint/appeal, replies/counter affidavits, affidavits, written statements, applications and other pleadings are drafted in such connected cases; full drafting fee will be admissible in the main case and only 20% separate drafting fee will be admissible in respect of each connected case.

4. In case of Outstation matters:

i. Boarding and Lodging Expenses shall be actual or a maximum of Rs. 2,500/-, Rs. 2,000/- and Rs. 1500/- per day (whichever is less) respectively for experience more than 15 years, 10 years & 5 years.

Outstation charges shall be Rs. 4,500/-, Rs. 3,000/- & Rs. 2,000/- per day respectively for experience more than 15 years.

iii. Travelling expenses (To & fro) shall be borne by CCI (on reimbursement basis on production of tickets) to a maximum of 2nd Tier AC in train. In case rail route is not available to a maximum of Rs. 9 per km by road

Taxes: On above Standard Fee Structure taxes will be deducted as per applicable rules and will be deposited to the concerned authorities directly GST will be paid extra to the fee as per rules if GST bill is provided by Counsel.

ANNEXURE 'D'

Disablement on the part of the Advocate/ Law Firm shall mean and include any of the following:

- 1. Giving false information in the Application for empanelment.
- 2. Handing over the brief or matter to another Advocate without prior written permission of the CCI.
- 3. Failure to attend the hearing of the case without any sufficient reason and/ or prior information.
- 4. Not acting as per the CCI instructions or going against specific instructions.
- 5. Not returning the brief when demanded or not allowing its inspection on demand.
- **6.** Misappropriation of the CCI funds or earmarking and using the same towards his fee without the CCI permission.
- 7. Threatening, intimidating or abusing any of the CCI employees, officers or representatives.
- 8. Making any associates or juniors to appear on behalf of any of the opposite parties in cases/appeal related to the CCI.
- Committing an act that tantamount to contempt of court or professional misconduct.
- 10. Conviction of the Advocate in any offence resulting into arrest or detention or disbarment by the Bar Council.
- 11. Passing on information related to the CCI on to the opposite parties or Advocate/s or any third party which is likely to cause any damage to the CCI interests.
- 12. Giving false or misleading information to the CCl related to the proceedings of the case; and
- 13. Seeking frequent adjournments or not objecting the adjournment moved by the other party without sufficient reason.
- 14. Dismissal or any adverse order in a case due to non-appearance of advocate.
